

OPEN SWIM AGE LIMITS

Children under 14 years of age must be accompanied by a parent or adult near the pool side during open swim. Children under 5 years of age, with or without a floatation device, may use the main pool, but must have an adult in the water to accompany them (diapers/swim diapers are not permitted in the main pool). You must have a valid drivers license to operate a golf cart in the parking lot, violation of this policy may cause your membership to be suspended.

GUEST FEE POLICY

The guest fee will be \$10 per guest on any day. Members may not bring the same guest more than 6 times during the summer and are asked to limit their guests to 4 per visit. Authorization by management is required at least one week in advance of bringing more than 4 guests .

CHILD CAREGIVER/GUARDIAN POLICY

Members who plan to use a permanent caregiver must fill out a Caregiver/Guardian Addition Form and obtain a Caregiver/Guardian Member card. The caregiver may only use the pool facilities with the member. One caregiver is allowed per family membership, and the cost is \$200.

THE SPLASH GRILLE

Pool side food service will be available daily for swim members and their guests.

Sandwiches, salads, snacks, ice cream, and beverages are some of the items which will be available. Michigan state law requires that all alcoholic beverages must be purchased at Twin Lakes, a licensed facility. Bags are subject to inspection by Twin Lakes staff. All food must be consumed in the designated areas of the pool deck.

SWIM FACILITY RULES

- One caregiver/babysitter may be added to a family swim membership for an additional fee.
- All members must sign in at the swim office and present their membership card and photo identification to use the swim facilities.
- Members must register guests at the swim office and pay the appropriate guest fee.
- Children who are not toilet-trained must wear a swim diaper and rubber swim bottoms in the toddler pool. Diapered children are not allowed in the main pool.
- Parents must accompany or be at poolside when their children are in the toddler pool.
- **Coolers are prohibited.** Small handheld lunchboxes are acceptable. Bags and lunchboxes are subject to inspection by Twin Lakes staff.
- Food orders from outside establishments may not be delivered or brought into the swim facility. All outside food must be consumed off premise.
- Food and beverages must be kept in designated areas. Please help keep the entire swim area clean. Members are asked to clean up after themselves.
- Glass within the pool enclosure is prohibited.
- Adults have priority use of the pool deck chaise lounges.
- Music players are only allowed with headphones
- Gum chewing is not allowed within the pool enclosure
- The entire swim facility is non-smoking.
- Commercial bathing suits only.
- No running, pushing or roughhousing.
- The pool will not be open when the outdoor temperature is 67 degrees or lower.

SWIM MEMBERSHIP

Swim memberships for the 2024 season include use of the swim club facility from May 25th through September 2nd. A family swim membership may include a set of parents, their children under the age of 23, and two grandparents.

Membership dues must be paid in full according to the payment plan described on the membership agreement. Failure to follow the payment plan may result in membership termination.

Memberships are non-transferable and non-refundable. If a family moves from the area, a membership refund could be given according to the following circumstances:

A. Notification before May 19, 2024

A full refund for initiation fees and dues, paid between November 1, 2023 and May 19, 2024, less a \$100 processing fee.

B. Notification by June 30, 2024

Half of the annual dues, paid between November 1, 2023 and June 30, 2024, refunded. Initiation fees are non-refundable

New members may be accepted through the summer if memberships are available.

Management reserves the right to refuse or cancel any membership, and to change or add written policies as is necessary.

The Main Pool will be used for Twin Lakes Swim Team practice during the early season, dates and times will be posted. The children's pool will remain open during these times.

The Main Pool will be used for Twin Lakes swim lessons during the regular season, dates and times will be posted. The children's pool will open at its scheduled time of 11:00am.

MEMBER HOUSE ACCOUNT POLICY

All Twin Lakes swim members, in good standing, are authorized to charge on their house account. The following guidelines apply to this privilege:

- Membership dues must be paid-in-full
- Membership card must be presented in order to make house account charges.
- Swim members 18 years of age and older are allowed house account charging privileges at all venues.
- Swim members 11 - 17 years of age are allowed house account charging privileges at the Splash Grille only
- A valid credit card must be on file with Twin Lakes and will be charged monthly for all house account charges.
- Charging privileges will be suspended for accounts that do not have a valid credit card on file.
- Member privileges will be suspended for accounts that do not have a valid credit card on file and are 30 days or more past due.
